Hosted an on-site event showcasing the progress made over the summer on constructing the folkhouse. The event was primarily for parents of students who had worked on the house, as well as for other community volunteers who had participated in reconstruction. Over forty people attended. John Flower, Jonathan Morrison, and Mathieu Lamaure, the leaders of the building effort, gave a lecture explaining the discoveries made about Chinese building techniques in the course of reconstruction and gave a demonstration of "hemcrete" creation, the method chosen for the next phase of building--the large curtain wall that surrounds the house.
