Over the summer, our camp had 27 student participants who volunteered to work with our crew to finish the interior wooden walls of the house, raising the timbers of the kitchen, and get our bathhouse closer to being up and running. In addition, we had another approximately 25 volunteers who have participated in similar work, and one volunteer who does pro-bono engineering work for us. A home school group continued to make weekly visit with an average 5 volunteers who worked 6 hours a week throughout the spring and fall of 2021 for a total of approximately 750 hours. All together, these volunteers logged approximately 2750 hours to which we can add Pam and John's work of approximately 3000 hours of volunteer work which covers both administrative work and site work. We hosted two events free of charge which each had approximately 50 participants. One was for a group of people who had cooperated in importing and donating ppe to US hospitals at the beginning of the Covid pandemic and the other event was for the Chinese American Museum of DC and their friends to get to know the China Folk House and open the way for future collaborative endeavors. A third event, also free of charge, was held for families who are part of the "First Day" consortium of the Baltimore Yearly Meeting of Friends to learn about the China Folk House, and that event had four student volunteers who served as hosts and about 30 families attending the tour. In addition, word of our project continues to grow in the community, and now each week approximately 10 to 15 drop in visitors arrive at the Folk House to learn about the project and see our progress, for a total of approximately 600 visits. We initiated a new cooperative venture with St. Stevens St. Agnes school in Northern Virginia to bring volunteers to CFHR to build a Japanese style ceramic kiln. Pam presented the project to the local Rotary Club of Charles Town West Virginia in December with 30-40 community leaders in attendance. We have continued to build our networks in the Washington area and in China in hopes that we
